## **POSITION STATEMENT**

### **EXPORT OF LIVESTOCK BY SEA FOR SLAUGHTER**

The practice of exporting farm livestock by sea from South Africa for the purpose of slaughter at an overseas destination is illogical and inherently prone to cause unnecessary and avoidable suffering in these animals. There is no rational or acceptable reason to transport livestock for long distances for long periods in poor, crowded conditions with many unavoidable hazards and risks, only to be slaughtered on arrival at the destination. The quality of the meat is likely to be affected. There are also no religious reasons why livestock cannot be slaughtered according to the required rites in South Africa at an export abattoir, and then the meat sent in refrigerated form overseas. This creates employment here and promotes food safety and security.

There is voluminous supportive evidence available to show that transporting livestock by sea is inherently dangerous to animal welfare and must therefore not be allowed. The international reputation of South Africa will be enhanced if we take a principled position against this inhumane and unacceptable practice. We therefore strongly recommend that further exports of live animals for the purpose of slaughter no longer be allowed and that a formal ban on this practice be instituted.


